Use Mandates

Prescriber - Mandatory PDMP Use

Effective Date(s): May 19, 2017

Details:

A practitioner, or the practitioner's authorized delegate, shall review a patient's controlled substance prescription history, as maintained in the prescription monitoring program, before the practitioner issues a prescription for a Schedule II controlled substance. The requirements of this section do not apply to: (1)a practitioner issuing a prescription for a Schedule II controlled substance to treat a hospice certified patient; (2)a practitioner issuing a prescription for a Schedule II controlled substance that does not exceed a five day supply for a patient; (3)a practitioner prescribing a Schedule II controlled substance for a patient with whom the practitioner has an established relationship for the treatment of a chronic condition; however, the practitioner must review the patient's controlled substance history maintained in the prescription monitoring program at least every three months; (4)a practitioner approving the administration of a Schedule II controlled substance by a health care provider licensed in South Carolina; (5)a practitioner prescribing a Schedule II controlled substance for a patient in a skilled nursing facility, nursing home, community residential care facility, or an assisted living facility and the patient's medications are stored, given, and monitored by staff; or (6)a practitioner who is temporarily unable to access the prescription monitoring program due to exigent circumstances; however, the exigent circumstances and the potential adverse impact to the patient if the prescription is not issued timely must be documented in the patient's medical record.
