Conference Call Agenda/Minutes

➤ Roll Call

Quorum established

➤ New Subcommittee Chair and Co-Chair

Jean Hall (KY) mentioned that Ron Larsen is the new chair of this subcommittee. She also mentioned that the PMIX by-laws were modified to allow co-chairs for the subcommittees. At the last Executive Committee meeting, Naresh Rajan, was appointed as co-chair for this subcommittee.

➤ Approval of Meeting's Minutes from 01-16-20

Motion to approve the minutes was made by Jean Hall (KY); seconded by Chad Garner (OH). Unanimously approved.

➤ PMIX Schema Workgroups

- Sync up elements query and response

Tom Carlson (Carlson Consulting) reviewed the different elements and responses from workgroup notes:

- Patient alerts will include a code table for the different alerts with description text. PDMPs will have the option to include them if they chose.
- Pharmacy's permit number/license number – ASAP codes with PHA is included in ASAP 4.2A, not previous versions. Leave this one for Schema WG 1 to sync up with ASAP.
- Treatment Type and Diagnosis Code – this one is also in ASAP 4.2A. make optional from PMIX perspective (it is situational in ASAP)
- XDEA Number – make a placeholder for y/n instead of the number itself;
- Date Sold and payment method - Leave this one for Schema WG 1 to sync up with ASAP.
- Pharmacist Name - Leave this one for Schema WG 1 to sync up with ASAP.
- Name of Animal - Leave this one for Schema WG 1 to sync up with ASAP
- MED Calculations – calculation should be determined by state receiving the data for each script to include part of ADME; need to make sure calculations are standardized; get PMIX group to recommend one.

- **New elements from PMIX Operations Subcommittee**

Jean Hall (KY) stated that the Operations subcommittee had identified some new elements to include with the schema; the new elements were based on new fields in ASAP. The other elements were alerts types. Tom Carlson (Carlson Consulting) began work on incorporating these elements and alerts in the schema. When finalized, the schema will be presented to the subcommittee for discussion. Below are the identified alert types:

- Overdose alerts – non-fatal OD, fatal OD
- Doctor/pharmacy shopping alerts – x doctors/x pharmacies/x time frame
- Overlapping prescription alerts – benzos and opioids
- MMEs alerts - >x amount of MMEs
- Marijuana alerts – marijuana registry
- Prescribing practice alerts – prescribing opioids more than 90 days, >640 patients in month; prescribing opioids to opioid naïve patient
- Naloxone dispensing alerts
- Dispensing practice alerts – early refills, multiple same day
- Conviction alerts – courts, convictions
- Law Enforcement alerts – suspected violations of statutes; stolen scripts
- Patient contract alerts – lock-in programs, pain/treatment contracts

Reports from both workgroups will be provided to the Technical Subcommittee members prior to the next conference call.
