Funding Education

- 2017 Department of Human Services received a SAMHSA SPF-Rx Grant
 - Subgrant to PMP for Prescriber Education
- Increase utilization of the PMP by speaking directly to prescribers of controlled substances.
- Education presented by the PMP as well as peers that are using the PMP successfully within their practices.
- Funded for four years, four regional sessions per year.

Process

- Contracted with the University of Minnesota, Office for Continuing Education
 - Continuing Education Credits
 - Registration
- Created an Education Review Committee
 - Referrals generated by support from Health Licensing Boards
- Recruiting Peer Speakers and site locations.....
- Promotion for registration (Event was free CE's)
- Email campaign waged by Health Licensing Boards, medical professional organizations, as well as our user database.

Results

<u>Successes</u>

- 97 Prescribers redeeming CEs
- 96% of attendees said they would recommend activity to a colleague
- 64% said they would make significant changes as a result of this conference
- 75% said they believe participation would improve their patient outcomes
- Great discussions, face to face interactions

Lessons Learned

- Contracting for CEs was a long process, very expensive per CE.
- Refreshments were sponsored by a partner at one session and this greatly increased engagement for participants
- Venue at each session was offered for free and staff was unable to view prior to event. Instructions and directions were challenging.
- Survey responses and online comments suggested online education availability

Distribution of Quick Tips

Previous Distribution

Mailed individually to new account holders

•Based on any address entered in account

Mailed monthly

- Returned mail
- •Costly!
- •Labor intensive monthly project

New Distribution Method

New AWARxE® accounts ask specifically for "Primary Work Location Address"

• No old information transferred over from RxSentry

Analyzed work location for accounts.

- Greater than 10 accounts with same address, sent batch.
 - •10 booklets
 - Letter to administration

Fulfilled additional requests received in response to letters.

New for 2020

- Producing series of 4 webinars (WebEx® software)
 - Registration and Survey directly through the software
- Not pursuing accreditation, seeking prior review and "endorsement" by prescribing health licensing boards.
 - Session 1: Understanding the PMP in Minnesota
 - Session 2: The New PMP AWARxE® Features and Utilization
 - Session 3: The MN PMP Prescriber Report A Self-Assessment Resource
 - Session 4: The AWARxE NarxCare® Report Understanding and Utilizing Analytics in the MN PMP
