# What is OD Insights?

The OD Insights solution **incorporates non-fatal overdose event data into a state's PDMP**, enabling this information to be displayed on Patient Reports within E-FORSCE.

This solution creates an opportunity for treating providers to **help prevent a repeat overdose** by linking individuals to needed follow-up care and services.


#### How Does OD Insights Work?

- Non-fatal overdose data ingested via stateprovided CSV, or ADT feeds through Patient Ping
  - Non-fatal overdose events identified via ICD-10 diagnosis codes
- Bamboo matches NFOD patient data against patient data received from other PDMP facilities in the state
- 3. NFOD data elements are surfaced in a PDMP tile and made visible to authorized PDMP Users in <u>AWARxE</u> and Gateway
