Data Elements for PMIX Schema

Jean Hall (KY) asked members for use case examples for patient alerts.

- 1. Suspected non-fatal overdose
- 2. Potential doctor shopping (5/5 alert)
- 3. Benzo and opiate combination
- 4. MMEs within certain range
- 5. Participants in medical marijuana registry (display leaf on patient)
- 6. # of acute pain prescriptions issued to patient
- 7. Naloxone dispensing
- 8. TTAC mentioned that they have information on elements on generating unsolicited reports and mandatory query conditions which could populate this list.

Jean Hall (KY) stated that these sound like it is just an indicator and text string which could easily be passed within PMIX exchange standard. Tom Carlson (Carlson Consulting) still need to develop a list of all the potential alerts for the schema to support.
